<b>Leaves &amp; Yard Waste:</b> Residential (must be hauled in by resident)	No Charge
<b>Leaves &amp; Yard Waste</b> Hauled in by Commercial Hauler:	
Pickup truck (Load is considered level with gunnels)	\$10.00 Load
Pickup w/Box	\$25.00 Load
All other vehicles	\$45.00 Load
Facility Decal Permit-first permit-resident/taxpayer .	\$20.00
<b>Facility Decal Permit</b> -second decal-same household	<i>No Charge</i>
<b>Facility Decal Permit</b> -each additional decal after first two	\$20.00 Replacement
Facility Decal Permit-if original decal presented	No Charge
<b>Replacement Facility Decal Permit</b> -if original not presented	\$20.00
<b>Coupon Booklet</b> (10 coupons) instead of second decal	No Charge
<b>2 Coupon Booklets</b> (20 coupons) instead of 2 decals	\$20.00
<b>Coupon booklet</b> (10 coupons)-each additional booklet	\$20.00
<b>Special One Day Refuse Permit</b> -one time facility use	\$2.00 per trip
<b>Mattresses or Box Springs</b> -stripped of metal (limit 2 per trip)	No Charge
<b>Mattresses or Box Springs</b> -containing metal	\$10.00 each
<b>Propane Tanks</b> Up to 20 lbs.	\$ 5.00 each
<b>Propane Tanks</b> -Over 20 lbs	\$25.00 each
<b>Fluorescent Bulbs</b>	\$ 0.15 cents/foot
<b>Monitor/TV units</b>	\$15.00 each
<b>Vehicle Tires</b> -6 to 10 Rims	\$ 2.00 each
<b>Vehicle Tires</b> -6 to 8 Rims	\$ 6.00 each
<b>Vehicle Tires</b> -8 or greater Rims	\$10.00 each
<b>All other Tires</b> (skidder, loader, heavy const, etc.) with NO RIMS	\$25.00 each
<b>White Goods</b> -refrigerators, air conditioners, freezers (Doors REMOVED)	\$20.00 each
<b>White Goods</b> -all other household appliances	\$13.00 each
